PERFORMANCE RESPONSIBILITIES:

- * (1) Plan, prepare, and conduct a variety of learning activities considering students' learning styles and special needs in order to enhance the application of critical, creative and evaluative thinking capabilities of students.
- * (2) Select, develop, modify and/or adapt materials, technology and resources to support learning objectives and address students' learning styles and special needs.
- * (3) Create or select goals and objectives for unit and daily plans based on a review of district and state curriculum priorities, student profiles and instructional priorities.
- * (4) Identify specific intended learning outcomes which are challenging, meaningful and measurable.
- * (5) Apply principles of learning and effective teaching in instructional delivery.
- * (6) Maintain academic focus by using a variety of motivational techniques.
- * (7) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
- * (8) Sequence content and activities appropriately.

- * (9) Maintain instructional momentum with smooth and efficient transitions from one activity to another.
- * (10) Provide instruction on safety procedures and proper handling of materials and equipment.
- * (11) Assist students in assessing, interpreting and evaluating information from multiple sources.
- * (12) Encourage self-assessment by students and assist them in developing plans for improving their performance, as appropriate.
- * (13) Monitor learning activities and provide feedback to students about the appropriateness of responses and quality of work with a focus on improving student performance.
- * (14) Evaluate the effectiveness of instructional units and teaching strategies.
- * (15) Interpret and use data (including but not limited to standardized and other test results) for diagnosis, instructional planning and program evaluation.
- * (16) Develop and use ongoing assessments to monitor student progress to verify that learning is occurring to adjust curriculum and instruction.
- * (17) Administer tests, including standardized tests, in accordance with directions provided, including proctoring and secure handling of materials.
- * (18) Communicate high learning expectations for all students.
- * (19) Foster student responsibility, appropriate social behavior, integrity, appreciation of cultural diversity, and respect for self and others by role modeling and learning activities.
- * (20) Communicate effectively, orally and in writing, with other professionals, students, and community.
- * (21) Provide accurate and timely information to students about academic and behavioral performance of students.
- * (22) Write or participate in the formation of student IEP or 504 Plans or any other learning plans based on individual student needs.
- * (23) Establish routines and procedures and encourage students to follow them consistently.
- * (24) Establish and maintain appropriate discipline and effective behavior management techniques.
- * (25) Demonstrate positive interpersonal relationships with students, peers, supervisors, and school/community.
- * (26) Collaborate with students, school staff and other appropriate persons to assist in meeting student needs.
- * (27) Work with other teachers in curriculum development, special activities and sharing ideas and resources.
- * (28) Demonstrate knowledge and understanding of curriculum content.
- * (29) Engage in continuing improvement of professional knowledge and skills, including instructional methodology, learning theory, curriculum trends and content.
- * (30) Develop and implement a Professional Development Plan annually in accordance with state and district requirements.
- * (31) Demonstrate punctuality and regular attendance.
- * (32) Assist in enforcement of school rules, administrative regulations and Board policy.
- * (33) Comply with policies, procedures and programs.
- * (34) Act in a professional and ethical manner and adhere at all times to the Code of Ethics and Principles of Professional Conduct.
- * (35) Maintain professional appearance in dress and grooming.
- * (36) Establish and maintain a positive, safe and non-threatening learning environment in which students are encouraged to be actively engaged in the learning process.

- *(37) Support school improvement initiatives by active participation in school activities, services and programs.
- *(38) Manage materials and equipment effectively.
- *(39) Instruct and supervise the work of volunteers and aides when assigned.
- *(40) Supervise students at all times to ensure a safe and orderly environment.
- *(41) Maintain a clean, attractive and organized learning environment.
- *(42) Maintain accurate and complete records in accordance with District procedures.
- *(43) Maintain confidentiality of student and other professional information.
- *(44) Maintain student grade, attendance, and conduct records in accordance with established procedures.

**Essential Performance Responsibilities*

PHYSICAL REQUIREMENTS:

Light Work: Exerting up to 20 pounds of force occasionally, and/or up to 10 pounds of force as frequently as needed to move objects.
