PERFORMANCE RESPONSIBILITIES:

- *(1) Plan, prepare, and conduct a variety of learning activities considering students' learning styles and special needs in order to enhance the application of critical, creative and evaluative thinking capabilities of students.
- *(2) Select, develop, modify and/or adapt materials, technology and resources to support learning objectives and address students' learning styles and special needs.
- *(3) Create or select goals and objectives for unit and daily plans based on a review of district and state curriculum priorities, student profiles and instructional priorities.
- *(4) Identify specific intended learning outcomes which are challenging, meaningful and measurable.
- *(5) Apply principles of learning and effective teaching in instructional delivery.
- *(6) Maintain academic focus by using a variety of motivational techniques.
- *(7) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
- *(8) Sequence content and activities appropriately.

- *(9) Maintain instructional momentum with smooth and efficient transitions from one activity to another.
