#### KNOWLEDGE, SKILLS AND ABILITIES:

Knowledge of child growth and development and especially of characteristics of students/children in the group assigned. Knowledge of prescribed curriculum. Basic understanding and knowledge of current technology. Knowledge of learning styles and skill in using varied teaching methods. Knowledge of current trends, research and best practices related to education. Knowledge of School Board policies and practices as they relate to teaching. Ability to handle problems, concerns and emotional distress with sensitivity and tact. Ability to communicate orally and in writing with students, parents, and others. Ability to plan, establish priorities and implement activities for maximum effectiveness. Ability to assess levels of student achievement effectively, analyze test results, and prescribe actions for improvement. Ability to maintain appropriate student supervision so that students have a safe and orderly environment in which to learn. Ability to work effectively with peers, administrators and others. ### **Administrative/Management**

- \* (6) Maintain a positive, organized and safe learning environment.

- \* (10) Enforce school rules, administrative regulations and Board policies.

- \* (22) Apply principles of learning and effective teaching in instructional delivery.
- \* (23) Use a variety of instructional strategies appropriate for teaching students from diverse backgrounds with different learning styles and special needs and which enhance the application of critical, creative and evaluative thinking capabilities.
- \* (24) Use appropriate material, technology, and other resources to help meet learning needs of all students.
- \* (25) Provide appropriate instructional modification for students with special needs, including exceptional education students and students who have limited English proficiency.
- \* (26) Recognize overt indicators of student distress or abuse and take appropriate action based on school procedures and law.
- \* (27) Provide instruction on safety procedures and proper handling of materials and equipment.
- \* (28) Foster student responsibility, appropriate social behavior, integrity, valuing of cultural diversity, and respect for self and others by role modeling and learning activities.
- \* (29) Assist students with health and hygiene needs as required.

- \*(30) Use appropriate technology in instructional delivery.
- \*(31) Use technology to establish an atmosphere of active learning.
- \*(32) Provide students with opportunities to use technology to gather and share information with others.
- \*(33) Facilitate student access to the use of electronic resources.
- \*(34) Explore and evaluate new technologies and their educational impact.
- \*(35) Use technology to review student assessment data.
- \*(36) Use technology for administrative tasks.

### Collaboration

- \*(37) Communicate effectively, both orally and in writing, with other professionals, students, parents and community.
- \*(38) Provide accurate and timely information to parents and students about academic and behavioral performance of students.
- \*(39) Collaborate with other professionals and parents after recognizing student distress or abuse.
- \*(40) Collaborate with peers and other professionals to enhance student learning.

### Staff Development

**TEACHER (Continued)**

**PHYSICAL REQUIREMENTS:**

Physical requirements may vary depending on particular assignment.

Light Work: Exerting up to 20 pounds of force occasionally and/or up to 10 pounds of force as frequently as needed to move objects.

Medium Work: Exerting up to 50 pounds of force occasionally, and/or up to 20 pounds of force frequently and/or up to 10 pounds of force as needed to move objects.

Heavy Work: Exerting up to 100 pounds of force occasionally, and/or up to 50 pounds of force frequently and/or up to 20 pounds of force as needed to move objects.

May be required to restrain a physically active individual as a temporary safety measure in accordance with School Board Policy 5.36.
